

# MESSAGE FROM THE RABBI AUGUST 2015

Dear friends,

I am about to begin my "vacation" – a considerable part of which will be devoted to preparing for the High Holy Days. As I said to some of you at our last Friday night service, "High Holy Day sermons don't write themselves!" So over the next month I'll be working and – I hope – relaxing a bit too.

For my bulletin message during this, my vacation month, I'm bringing in a guest author – Rabbi David Kaufman, who writes for the centrist blog, "WeAreForIsrael."

First, to place Rabbi Kaufman's remarks in context, this is from the "WeAreForIsrael" mission statement:

"We Are For Israel is a forum of people who support Israel, who are deeply concerned by the drift in much of world opinion that has made it legitimate to single out Israel for blame and censure in respect of the Israeli/Palestinian conflict. While we recognize that Israel shares some responsibility for the current state of affairs, we believe that the roots of the conflict and its broader dimensions are much more complex than is generally presented.

Attempts by Israel's detractors to lay the blame for the lack of progress toward peace at her door while pressing her alone to make concessions are not only unjustified, but frequently motivated by political interests, naivety, ignorance, misinformation or even anti-Semitism.

We are particularly concerned by the manner in which some organizations within the Jewish community, which profess to care for Israel and her well-being, advocate that pressure be applied upon her to make unilateral concessions. Similar demands are not made of the Palestinians to respond in kind if at all. We believe that such advocacy, which results in intransigence and increased demands from the Palestinians, does not advance the cause of peace. In discrediting Israel publicly, such organizations not only weaken support for her but also serve the interests of her detractors and enemies.

At a time when it has become fashionable to castigate Israel for unrest in the Middle East and elsewhere, we appeal to Jews everywhere to respond to criticism of Israel with support and to advocate on her behalf."

Below is Rabbi Kaufman's latest posting. WeAreForIsrael has several other, more detailed analyses of the Iran agreement. I encourage you to read them and many of the other entries on this blog which, in the often cacophonous babble of public voices on Israel, stands out as a beacon of reason, keen analysis, moderation and unwavering support for the State of Israel. #### Holocaust Imagery and the Iran Deal

I have been thinking of how many friends of mine, including Holocaust survivors - may their memories be for a blessing - would react to the debate concerning the agreement with Iran. I cannot help but feel that they would be distressed by what they would be hearing. Much of the debate is simply vile.

Friends, while the Iran Deal poses serious concerns for some of us, it is an attempt to keep the worst weapon out of the hands of the most dangerous nation. The use of Holocaust imagery and references to describe supporters of that agreement is inappropriate to its reality and to their advocacy, deeply offensive to the memory of the Holocaust, and does not promote the needed atmosphere of debate.

Good people who care about Israel and Jews can debate the effectiveness of the agreement and can discuss its merits and its failings. While some may be in great fear over the impact of this agreement on Israel and the region, certainly they must also fear what might happen should Iran acquire a nuclear weapon!

**Let us not demonize each other**. Supporters of this deal are not [insert inappropriate Holocaust imagery here], and opponents who are showing concern about some of its provisions are not "warmongers."

The Holocaust was the greatest evil the world has yet seen. My friends, it is not 1939. It is 2015. Thankfully, there is a strong and vibrant Jewish state with a great ability to defend itself, something not remotely the case 76 years prior. The well-being of that Jewish state depends significantly on bipartisan support in America and the well-being of that Jewish state has been cited as and is a primary concern of many of those on both sides of the issue at hand in America.

Let us not do an injustice to the memory of the Holocaust—to those who died, to those who survived, to the heroes and martyrs—by evoking those images in this debate among those on both sides who very much wish to avoid another Holocaust.

So, Presidential candidates, if you're reading this,

It is highly inappropriate, heinous and offensive, to call supporters of the agreement something that seeks to connect them with the Nazis, or portrays opponents of the agreement in the traditional anti-Semitic depiction of Jews as the promoters of warfare, calling them warmongers!
